#### 132. THE ENVIRONMENTAL AND REGENERATION COMMITTEE

#### 135. BUDGET 2023/24

Members received the Town Clerks proposed budget report, on the budget proposals, for the financial year 2023/24. Members approved a 0% increase in the precept for the 2023/24 financial year of £42.97 that would fund expenditure of £83, 948.

Members approved the budget for 2023-24 and asked for further budget forecasting, to be done with the Finance and General Purposes Committee, to help members better understand the budgeting process.

The Clerk had received two proposals to be drawn down form reserves.

- £5k be drawn down from reserves to support Saltney Town FC for improvements.
- £5k be drawn from reserves to move the 5-year plan forward ready to go out to consultation.

## **RESOLVED:** That

- (1) the budget sum of £83,948 be approved and submitted to Flintshire County Council with a 0% increase precept will remain at £42.97 for the financial year 2023-24.
- (2) the following items be drawn down from reserves in the 2023-24 financial year:-
  - approx. £4,579 be drawn down from reserves to top up the budget.
  - £5k be drawn down from reserves to support Saltney Town FC for improvements.
  - £5k be drawn from reserves to move the 5-year plan forward ready. to go out to consultation.

## 136. CALENDAR OF MEETINGS 2023

Members were asked to consider the calendar of meetings for 2023. It was agreed that the calendar of meetings could be subject to change throughout the year.

#### 137. SUMMER PLAYSCHEMES FOR 2023

The latest position from Flintshire County Council on the summer playschemes for 2023. As in previous years, a minimum three week offer with the potential to purchase additional weeks 4,5 and 6.

Cost of a 3-week playscheme from Monday 24 July 2023 – Each location, comprising.

- 15 sessions
- 10 hours per week, per location
- 2 hours Monday to Friday
- AM or PM (10:30 am 12:30 & 2:00 pm 4:00 pm)
- Local locations are completely at your Council's discretion.

Cost for 3 weeks – Team on site; Training hours and Supervision. - £1,595.80. Additional weeks can be purchased at a cost of £531.00 for each site location.

The above costings are on the level of grant funding received from Welsh Government for 2022. Flintshire County Council were still awaiting direction from Welsh Government on final costings for 2023.

## **RESOLVED:** That

Flintshire County Council be informed Saltney Town Council's contribution and participation would be for three weeks on the Rec, Park Avenue, Saltney at a cost of £1595.80 for the summer play schemes 2023.

# 138. REQUEST FOR A COMMUNITY DONATION – WALES AIR AMBULANCE

At Wales Air Ambulance, the mission was to deliver lifesaving advanced medical care to people across Wales whenever and wherever they need it. They were on standby 24/7, 365 days a year and in 2021 attended 3544 missions, with 81 in the Flintshire region.

Members considered the request and agreed to give a community donation contribution of £500.

## **RESOLVED:** That

a community donation of £500 be given to Wales Air Ambulance.

# 139. PRACTITIONERS' CONFERENCE 2023

Members recalled that at the Council meeting held on 9 November 2022 Minute No. 120 refers, the Clerk asked members to rescind the decision as the cost of the conference was excessive at £600 for both days inclusively.

# 140. CONSULTATION ON THE DRAFT WELL-BEING PLAN 2023-2028

The Well-Being of Future Generations (Wales) Act 2015 (the 'Act') placed a duty on specified public bodies to work together, under a Public Services Board, to improve local well-being in their area, supporting the achievement of the seven well-being goals for Wales.

The Act also required Public Services Boards to periodically prepare and publish an assessment of the economic, social, environmental, and cultural well-being of its area. The most recent Assessment of Well-being in Flintshire was published in May 2022 and was now using this to inform the next Well-being Plan 2023 to 2028, that would set out objectives for improving local well-being.

Members had considered the Public Services Board Drafted Well-being Plan 2023-2028 and agreed not to make any further comments at this time.

Saltney Town Council did not wish to submit any comments on the Public Services Board drafted Well-being Plan 2023 to 2028.
